Payment Methods

Payments may be made by check, money order, cash, or bank transfer (ACH). Credit cards are accepted with an added 3% processing fee payable by the card holder. Checks and money orders are to be made out to Maple Village Waldorf School.

Payment of Dues, Refund Policy, and Termination Conditions

a. Signing this contract indicates financial agreement by the Parent(s)/Guardian(s). The Parent(s)/Guardian(s) shall be financially responsible for the annual dues as noted in this contract for the 2019-2020 school year. The Parent(s)/Guardian(s) understand and agree that selecting a monthly payment plan, as listed above, is a convenience to the Parent(s)/Guardian(s) and shall not provide them with an exemption from the annual dues liability. _____

b. If the Parent(s)/Guardian(s) select a monthly payment plan, first month's dues are due on or before July 1, 2019. c. Parent/Guardian agrees to give MVWS Parent Participation Preschool at least 30 days written notice in the event a child needs to leave the school before the academic year-end. Included in the letter shall be the reason for withdrawal and a formal request for the Board to review your contract and open account balance. The Board shall reserve the right to provide a refund under extenuating circumstances, shall determine an amicable financial agreement to settle the account balance due to MVWS Parent Participation Preschool or shall request the entire account balance be paid in full. _____

d. Dues payments shall be received by the 1st of each month. All payments received after the 1st day of each month shall be subject to a late fee of \$50. If payments cannot be made in a timely manner, it is the Parent's obligation to contact the Business Administrator immediately. Continued nonpayment shall result in the dismissal of the student from the program. _____

e. Repeated violations of policies set forth in the Parent Handbook may result in a Board decision of MVWS Parent Participation Preschool to terminate the contract between the family and school. _____

By enrolling our child at Maple Village Waldorf School, the undersigned Parent(s)/Guardian(s), and on behalf of each of my/our heirs, beneficiaries, administrators, representatives, next of kin, spouse, and assigns, hereby gives permission for my/our child named above to participate in all school activities, and expressly release, discharge, waive and relinquish all claims, demands, causes of action, liability, loss or damages, for injury to persons or property, including wrongful death, whether actual or alleged, against Maple Village Waldorf School, its Board of Trustees, its Committee Members, and individual

members thereof, and all Maple Village Waldorf School employees, volunteers, and agents, arising out of or incident to our child's participation in school activities, whether or not such claims, demands, causes of action, liability, loss, or damages arise out of the negligence (passive or active), strict liability, or otherwise of Maple Village Waldorf School, its Board of Trustees, Committee Members, and individual members thereof, and all Maple Village Waldorf School employees, volunteers, and agents. The undersigned also agrees to defend, indemnify and hold Maple Village Waldorf School and its Board of Trustees harmless from any and all damages caused by our child. _____

All adults working in the classroom are subject to a TB test and LiveScan background check at their expense. _____

The undersigned have had the opportunity to ask any questions about this contract and understand that this contract contains the entire agreement related to matters specified herein, and supersedes any prior written or oral statements or agreements related to such matters. Amendments or alterations to this contract may only be made with the express written consent of all parties.

This Enrollment Contract shall be interpreted in accordance with the laws of the State of California. It is agreed that any dispute or cause of action arising between the parties, whether out of this Enrollment Contract or otherwise, can only be brought in a court located in Los

Angeles County. If it becomes necessary for Maple Village Waldorf School Parent Participation Preschool to initiate legal action against the undersigned Parent(s)/Guardian(s) in connection with the child named herein, the undersigned agree to pay all legal fees, whether or not a judicial proceeding is initiated and court costs resulting from the initiation of any such legal proceedings.

The undersigned understand and agree that as the Parent(s)/Guardian(s) signing this Enrollment Contract, they are bound by the provisions of this contract and are personally responsible for the financial obligations of the child named herein.
